Superiority by a Margin Tests for Two Survival Curves Using Cox's Proportional Hazards Model

Introduction

A clinical trial may be employed to test the clinical superiority of a treatment over a control with regards to their survival distributions. Because survival times are not normally distributed and because some survival times are censored, Cox proportional-hazards regression is often used to analyze the data. The formulation for testing the significance of a Cox regression coefficient is identical to the standard logrank test. Thus, the power and sample size formulas for one analysis also work for the other.

The Cox Regression model has the added benefit over the exponential model that it does not assume that the hazard rates are constant, but only that they are proportional. That is, that the hazard ratio remains constant throughout the experiment, even if the hazard rates vary.

This procedure is documented in Chow, Shao, and Wang (2008) which summarizes the work of Schoenfeld (1981, 1983). Note that there was an error in Chow, Shao, and Wang (2008) page 179 which caused the sample size to be doubled. This error has been corrected in this edition.

Technical Details

Cox's Proportional Hazards Regression

Cox's proportional hazards regression is widely used for survival data. The regression model is

$$h(t | z) = h(t | 0) \exp(bz)$$

where

b is the regression coefficient which is equal to $\log[h(t | 1)/h(t | 0)] = \log(HR)$

z is a binary indicator variable of treatment group

t is elapsed time

$h(t/z)$ is the hazard rate at time t , given covariate z

HR is the hazard ratio $h(t | 1)/h(t | 0)$

Clinical Superiority Hypothesis

Lower Hazards Better

Assuming that lower hazard rates are better, clinical superiority means that the treatment hazard rate is lower than the control hazard rate by a clinically significant amount. We find it more convenient to state the hypotheses in terms of the hazard ratio, HR , rather than the Cox regression coefficient, b . Remembering that $b = \log(HR)$ and assuming that $HR_0 < 1$, clinical superiority requires that $HR < HR_0$. Here, HR_0 is the ratio of clinical insignificance or the clinical superiority ratio.

The statistical hypotheses that results in the conclusion of clinical superiority when the null hypothesis is rejected is

$$H_0: \log(HR) \geq \log(HR_0) \quad \text{versus} \quad H_a: \log(HR) < \log(HR_0)$$

Higher Hazards Better

Assuming that higher hazard rates are better, clinical superiority means that the treatment hazard rate is higher than the control hazard rate by a clinically significant amount. We find it more convenient to state the hypotheses in terms of the hazard ratio, HR , rather than the Cox regression coefficient, b . Remembering that $b = \log(HR)$ and assuming that $HR_0 > 1$, clinical superiority requires that $HR > HR_0$. Here, HR_0 is called clinical superiority.

The statistical hypotheses that results in the conclusion of clinical superiority when the null hypothesis is rejected is

$$H_0: \log(HR) \leq \log(HR_0) \quad \text{versus} \quad H_a: \log(HR) > \log(HR_0)$$

Test Statistic

It can be shown that the test of b based on the partial likelihood method of Cox (1972) coincides with the common logrank test statistic. When testing superiority by a margin, you can use b from a Cox regression or calculate the modified logrank statistic as follows

Logrank Test

The logrank test statistic is

$$L = \frac{\sum_{k=1}^K \left(I_k - \frac{Y_{1i}HR_0}{Y_{1i}HR_0 + Y_{2i}} \right)}{\left[\sum_{k=1}^K \left(\frac{Y_{1i}Y_{2i}HR_0}{(Y_{1i}HR_0 + Y_{2i})^2} \right) \right]^{-\frac{1}{2}}}$$

where K is the number of deaths, Y_{ij} is the number of subjects at risk just prior to the j^{th} observed event in the i^{th} group, and I_k is a binary variable indicating whether the k^{th} event is from group 1 or not.

The distribution of L is approximately normal with mean $(\log(HR) - \log(HR_0))\sqrt{P_1P_2dN}$ and unit variance, where

P_1 is the proportion of N that is in the control group

P_2 is the proportion of N that is in the treatment group

N is the total sample size

N_1 is the sample size from the control group, $N_1 = N(P_1)$

N_2 is the sample size from the treatment group, $N_2 = N(P_2)$

Pev_1 is probability of the event of interest in the control group

Pev_2 is probability of the event of interest in the treatment group

d is the overall probability of an event, $d = Pev_1P_1 + Pev_2P_2$

b is the Cox regression coefficient, $b = \log(HR)$

Power Calculations

The power of this test is given by

$$\Phi \left((\log(HR_0) - \log(HR_1))\sqrt{P_1P_2dN} - z_{1-\alpha} \right)$$

where HR_1 is the actual value of the hazard ratio under the alternative hypothesis.

Procedure Options

This section describes the options that are specific to this procedure. These are located on the Design tab. For more information about the options of other tabs, go to the Procedure Window chapter.

Design Tab

The Design tab contains most of the parameters and options that you will be concerned with.

Solve For

Solve For

This option specifies the parameter to be solved for from the other parameters. The parameters that may be selected are *Power* or *Sample Size*. Select *Sample Size* when you want to calculate the sample size needed to achieve a given power and alpha level. Select *Power* when you want to calculate the power.

Test Direction

Higher Hazards Are

Select the direction of the alternative hypothesis, H_a . In most studies, a lower hazard rate is better since it indicates a longer life-time. However, in some situations, a higher hazard rate is desired. For example, if the length of life of disease organisms is being studied. This option lets you specify which option you have.

Each option results in different null and alternative hypotheses.

- **Worse ($H_a: HR < HR_0$)**

In this case lower is better. The alternative hypothesis is that hazard ratio is lower than a clinically significant value called the clinical superiority ratio, HR_0 .

- **Better ($H_a: HR > HR_0$)**

In this case higher is better. The alternative hypothesis is that hazard ratio is higher than a clinically significant value called the clinical superiority ratio, HR_0 .

Power and Alpha

Power

This option specifies one or more values for power. Power is the probability of rejecting a false null hypothesis and is equal to one minus Beta. Beta is the probability of a type-II error, which occurs when a false null hypothesis is not rejected. In this procedure, a type-II error occurs when you fail to reject the null hypothesis of equal survival curves when in fact the curves are different.

Values must be between zero and one. Historically, the value of 0.80 (Beta = 0.20) was used for power. Now, 0.90 (Beta = 0.10) is also commonly used.

A single value may be entered here or a range of values such as *0.8 to 0.95 by 0.05* may be entered.

Superiority by a Margin Tests for Two Survival Curves Using Cox's Proportional Hazards Model

Alpha

This option specifies one or more values for the probability of a type-I error. A type-I error occurs when you reject the null hypothesis of equal survival curves when in fact the curves are equal.

Values of alpha must be between zero and one. Historically, the value of 0.05 has been used for alpha. This means that about one test in twenty will falsely reject the null hypothesis. You should pick a value for alpha that represents the risk of a type-I error you are willing to take in your experimental situation.

You may enter a range of values such as *0.01 0.05 0.10* or *0.01 to 0.10 by 0.01*.

Sample Size (When Solving for Sample Size)

Group Allocation

Select the option that describes the constraints on $N1$ or $N2$ or both.

The options are

- **Equal ($N1 = N2$)**
This selection is used when you wish to have equal sample sizes in each group. Since you are solving for both sample sizes at once, no additional sample size parameters need to be entered.
- **Enter $N2$, solve for $N1$**
Select this option when you wish to fix $N2$ at some value (or values), and then solve only for $N1$. Please note that for some values of $N2$, there may not be a value of $N1$ that is large enough to obtain the desired power.
- **Enter $R = N2/N1$, solve for $N1$ and $N2$**
For this choice, you set a value for the ratio of $N2$ to $N1$, and then PASS determines the needed $N1$ and $N2$, with this ratio, to obtain the desired power. An equivalent representation of the ratio, R , is

$$N2 = R * N1.$$
- **Enter percentage in Group 1, solve for $N1$ and $N2$**
For this choice, you set a value for the percentage of the total sample size that is in Group 1, and then PASS determines the needed $N1$ and $N2$ with this percentage to obtain the desired power.

$N2$ (Sample Size, Group 2)

This option is displayed if Group Allocation = "Enter $N2$, solve for $N1$ "

$N2$ is the number of items or individuals sampled from the Group 2 population.

$N2$ must be ≥ 2 . You can enter a single value or a series of values.

R (Group Sample Size Ratio)

This option is displayed only if Group Allocation = "Enter $R = N2/N1$, solve for $N1$ and $N2$."

R is the ratio of $N2$ to $N1$. That is,

$$R = N2 / N1.$$

Use this value to fix the ratio of $N2$ to $N1$ while solving for $N1$ and $N2$. Only sample size combinations with this ratio are considered.

$N2$ is related to $N1$ by the formula:

$$N2 = [R \times N1],$$

where the value $[Y]$ is the next integer $\geq Y$.

Superiority by a Margin Tests for Two Survival Curves Using Cox's Proportional Hazards Model

For example, setting $R = 2.0$ results in a Group 2 sample size that is double the sample size in Group 1 (e.g., $N1 = 10$ and $N2 = 20$, or $N1 = 50$ and $N2 = 100$).

R must be greater than 0. If $R < 1$, then $N2$ will be less than $N1$; if $R > 1$, then $N2$ will be greater than $N1$. You can enter a single or a series of values.

Percent in Group 1

This option is displayed only if Group Allocation = "Enter percentage in Group 1, solve for $N1$ and $N2$."

Use this value to fix the percentage of the total sample size allocated to Group 1 while solving for $N1$ and $N2$. Only sample size combinations with this Group 1 percentage are considered. Small variations from the specified percentage may occur due to the discrete nature of sample sizes.

The Percent in Group 1 must be greater than 0 and less than 100. You can enter a single or a series of values.

Sample Size (When Not Solving for Sample Size)

Group Allocation

Select the option that describes how individuals in the study will be allocated to Group 1 and to Group 2.

The options are

- **Equal ($N1 = N2$)**
This selection is used when you wish to have equal sample sizes in each group. A single per group sample size will be entered.
- **Enter $N1$ and $N2$ individually**
This choice permits you to enter different values for $N1$ and $N2$.
- **Enter $N1$ and R , where $N2 = R * N1$**
Choose this option to specify a value (or values) for $N1$, and obtain $N2$ as a ratio (multiple) of $N1$.
- **Enter total sample size and percentage in Group 1**
Choose this option to specify a value (or values) for the total sample size (N), obtain $N1$ as a percentage of N , and then $N2$ as $N - N1$.

Sample Size Per Group

This option is displayed only if Group Allocation = "Equal ($N1 = N2$)."

The Sample Size Per Group is the number of items or individuals sampled from each of the Group 1 and Group 2 populations. Since the sample sizes are the same in each group, this value is the value for $N1$, and also the value for $N2$.

The Sample Size Per Group must be ≥ 2 . You can enter a single value or a series of values.

$N1$ (Sample Size, Group 1)

*This option is displayed if Group Allocation = "Enter $N1$ and $N2$ individually" or "Enter $N1$ and R , where $N2 = R * N1$."*

$N1$ is the number of items or individuals sampled from the Group 1 population.

$N1$ must be ≥ 2 . You can enter a single value or a series of values.

Superiority by a Margin Tests for Two Survival Curves Using Cox's Proportional Hazards Model**N2 (Sample Size, Group 2)**

This option is displayed only if Group Allocation = "Enter N1 and N2 individually."

$N2$ is the number of items or individuals sampled from the Group 2 population.

$N2$ must be ≥ 2 . You can enter a single value or a series of values.

R (Group Sample Size Ratio)

*This option is displayed only if Group Allocation = "Enter N1 and R, where $N2 = R * N1$."*

R is the ratio of $N2$ to $N1$. That is,

$$R = N2/N1$$

Use this value to obtain $N2$ as a multiple (or proportion) of $N1$.

$N2$ is calculated from $N1$ using the formula:

$$N2 = [R \times N1],$$

where the value $[Y]$ is the next integer $\geq Y$.

For example, setting $R = 2.0$ results in a Group 2 sample size that is double the sample size in Group 1.

R must be greater than 0. If $R < 1$, then $N2$ will be less than $N1$; if $R > 1$, then $N2$ will be greater than $N1$. You can enter a single value or a series of values.

Total Sample Size (N)

This option is displayed only if Group Allocation = "Enter total sample size and percentage in Group 1."

This is the total sample size, or the sum of the two group sample sizes. This value, along with the percentage of the total sample size in Group 1, implicitly defines $N1$ and $N2$.

The total sample size must be greater than one, but practically, must be greater than 3, since each group sample size needs to be at least 2.

You can enter a single value or a series of values.

Percent in Group 1

This option is displayed only if Group Allocation = "Enter total sample size and percentage in Group 1."

This value fixes the percentage of the total sample size allocated to Group 1. Small variations from the specified percentage may occur due to the discrete nature of sample sizes.

The Percent in Group 1 must be greater than 0 and less than 100. You can enter a single value or a series of values.

Sample Size – Proportion of Events Observed**Pev1 (Probability of a Control Event)**

Enter one or more values for $Pev1$, the average probability of an event (death) for each individual in the control group. The number of events in the control group is equal to $Pev1 \times N1$.

Range

$$0 < Pev1 < 1$$

Superiority by a Margin Tests for Two Survival Curves Using Cox's Proportional Hazards Model

Pev2 (Probability of a Treatment Event)

Enter one or more values for $Pev2$, the average probability of an event (death) for each individual in the control group. The number of events in the control group is equal to $Pev2 \times N2$.

Range

$0 < Pev2 < 1$

Effect Size

HR1 (Actual Hazard Ratio)

Specify one or more hazard ratios, $HR1$, at which the power is calculated. HR is defined as the treatment hazard rate ($h2$) divided by the control hazard rate ($h1$). $HR1$ represents the assumed value at which the power of rejecting $H0$ is calculated. In clinical superiority tests, this ratio must be lower (or higher) than $HR0$.

Range

If lower hazards are better, the range is $0 < HR1 < HR0 < 1$. Typical values are between 0.1 and $HR0$.

If higher hazards are better, the range is $HR1 > HR0 > 1$.

Press the "Survival Parameter Conversion Tool" button to estimate reasonable values based on median survival times, hazard rates, or the proportion surviving.

HR0 (Superiority Hazard Ratio)

$HR0$ is the largest or smallest that the hazard ratio can be and still conclude clinical superiority.

Range

If lower hazards are better, the range is $0 < HR1 < HR0 < 1$.

If higher hazards are better, the range is $HR0 > 1$ and $HR0 < HR1$.

Example 1 – Finding the Sample Size

A researcher is planning a clinical superiority trial using a parallel, two-group, equal sample allocation design to compare the survivability of a new treatment with that of the current treatment. The clinical superiority ratio is 0.75. The desired power is 0.90 and significance level is 0.025. HR will be between 0.2 and 0.5. The probability of observing an event is 0.50 in the control group and 0.30 in the treatment group.

Setup

This section presents the values of each of the parameters needed to run this example. First, from the PASS Home window, load the **Superiority by a Margin Tests for Two Survival Curves Using Cox's Proportional Hazards Model** procedure window by expanding **Survival**, then **Two Survival Curves**, then clicking **Superiority by a Margin**, and then clicking on **Superiority by a Margin Tests for Two Survival Curves Using Cox's Proportional Hazards Model**. You may then make the appropriate entries as listed below or open **Example 1** by going to the **File** menu and choosing **Open Example Template**.

Superiority by a Margin Tests for Two Survival Curves Using Cox's Proportional Hazards Model

Report Definitions

Power is the probability of rejecting a false null hypothesis. Power should be close to one.

N is the total sample size.

N1 and N2 are the sample sizes of the control and treatment groups, respectively.

%N1 is the percent of the total sample that is in group 1, the control group.

HR = h_2/h_1 is the hazard ratio.

HR1 is the actual hazard ratio at which power is calculated.

HR0 is the superiority hazard ratio.

Pev1 and Pev2 are the probabilities of an event in the control and the treatment groups, respectively.

E1 and E2 are the number of events required in the control and the treatment groups, respectively.

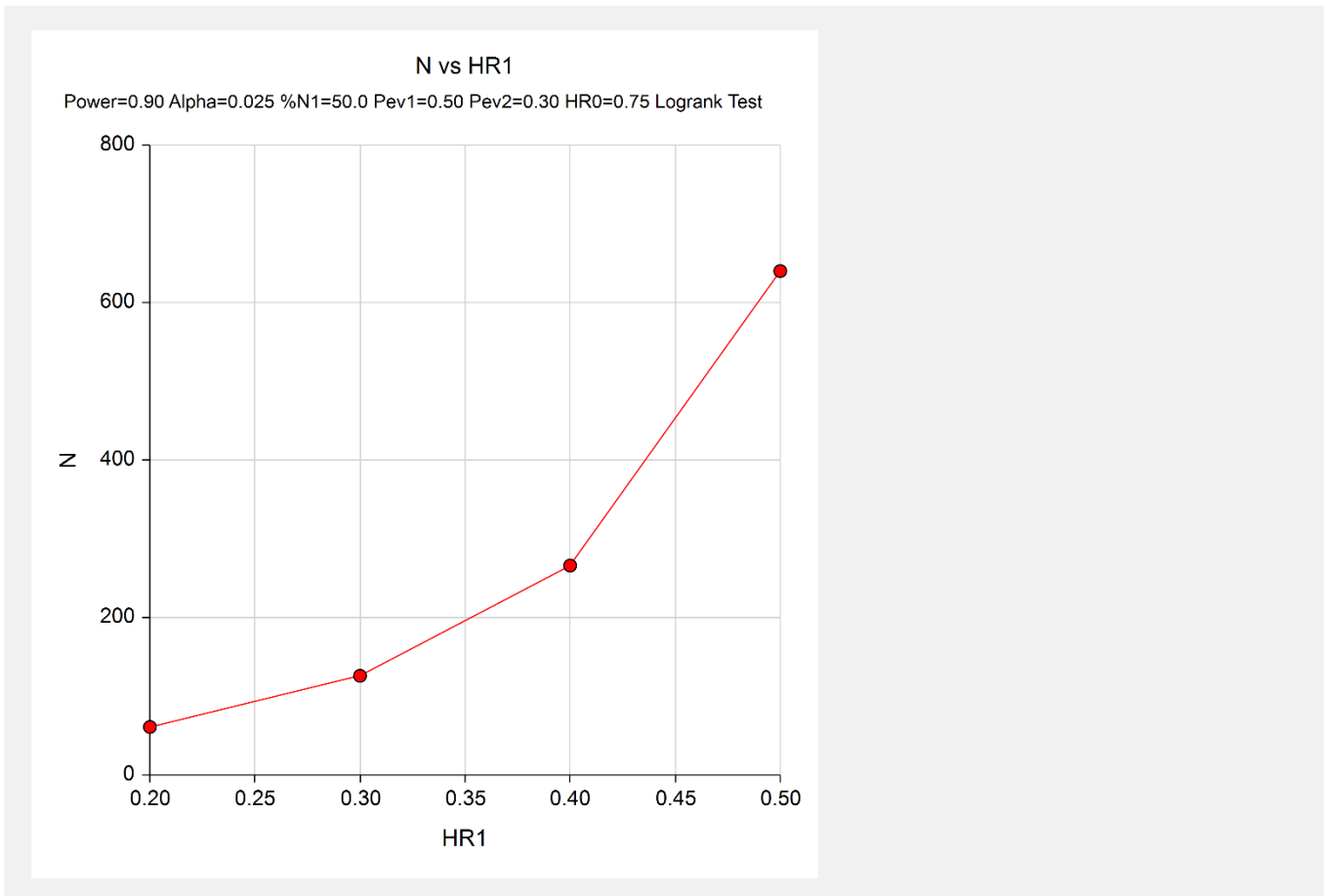
Alpha is the probability of rejecting a true null hypothesis.

Summary Statements

A superiority by a margin test with an overall sample size of 61 subjects (of which 30 are in the control group and 31 are in the treatment group) achieves 90% power at a 0.025 significance level when the superiority bound is 0.750 and the hazard ratio is actually 0.200. The number of events required to achieve this power is 24.3. It is anticipated that the proportion of subjects in which the event is observed during the study is 0.500 for the control group and 0.300 for the treatment group. These results assume that the hazard ratio is constant throughout the study and that Cox proportional hazards regression or the clinical superiority logrank test is used to analyze the data.

These reports show the values of each of the parameters, one scenario per row.

Plots Section



This plot shows the relationship between HR and N.

Example 2 – Validation using Chow et al. (2008)

Chow et al. (2008) page 179 present an example that we will use for validation. In their example, $HR1 = 2$, $\log(HR0) = 0.3$, $Pev1 = Pev2 = 0.8$, $P1 = 0.5$, $\alpha = 0.05$, and $\text{power} = 0.8$. They should have obtained a value of about 100 per group (this is a correction to Chow et al.'s example in which they obtained 200).

Setup

This section presents the values of each of the parameters needed to run this example. First, from the PASS Home window, load the **Superiority by a Margin Tests for Two Survival Curves Using Cox's Proportional Hazards Model** procedure window by expanding **Survival**, then **Two Survival Curves**, then clicking **Superiority by a Margin**, and then clicking on **Superiority by a Margin Tests for Two Survival Curves Using Cox's Proportional Hazards Model**. You may then make the appropriate entries as listed below, or open **Example 2** by going to the **File** menu and choosing **Open Example Template**.

PASS has also calculated the value of $N = 201$ which is within rounding of the 200 that Chow calculated.
